**1. HOW TO ENTER**

The Contest begins on **NOVEMBER 2, 2023**, at **07:45 AM PST** and ending on **NOVEMBER 30, 2023**, at **07:45 AM PST** (“Contest Dates”). Entrants may enter on-air only.
- b. To enter the Contest, entrant may enter on-air beginning on **NOVEMBER 2, 2023**, at **07:45 AM PST** and ending on **NOVEMBER 30, 2023**, at **07:45 AM PST** (“Entry Period”).
  - i. To enter on-air, listen to the Station each weekday beginning on **NOVEMBER 2, 2023**, at **07:45 AM PST** and ending on **NOVEMBER 30, 2023**, at **07:45 AM PST** during the Entry Period for the air personality to announce the cue to call. Upon hearing the cue to call, designated caller (as announced by the on-air personality prior to the cue to call) to get through to the Station contest line: 916-339-1140, will win a prize upon confirmation of eligibility **AFTER CORRECTLY DESCRIBING THE DETERMINED “JIFFY LUBE PLAY OF THE GAME” FROM Game 4-Kings v GSW, Game 5-Kings v HOU, Game 6-Kings v HOU, Game 7-Kings v POR, Game 8-Kings v OKC, Game 9-Kings v CLE, Game 10-Kings v LAL, Game 12-Kings v DAL, Game 13-Kings v NOP, Game 15-Kings v MIN, Game 16-Kings v GSW, and Game 17-Kings v LAC.** At the time of entrant’s call, entrant will be required to provide all information requested including entrant’s full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted as addresses. In the event that the selected caller is disconnected or is found to be ineligible, that caller

will not win a prize and the next eligible caller who successfully makes it through on the call-in line and completes the call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once during the Contest. Multiple participants are not permitted to share the same phone number, and only one phone number may be used per entrant.

- c. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.
- d. Only one (1) entry per person is permitted. There will be up to a total of **TWELVE (12)** winner(s) selected in the Contest.
- e. All entries must be received by the end of the Entry Period.

## **2. ELIGIBILITY RESTRICTIONS**

- a. The Contest is open to all persons who are legal U.S. residents of the state of **CALIFORNIA**, eighteen (18) years of age or older, and who reside in one of the **SIX (6)** jurisdictions that make up the listening area includes **Yolo, Sacramento, Sutter, Nevada, Placer, and El Dorado Counties**. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.
- c. Unless the Station otherwise specifies, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the Bonneville International Radio Stations are subject to the following restrictions: Persons who have won a prize valued up to \$100 in the thirty (30) days prior to **"NOVEMBER 2023 - JIFFY LUBE'S 'PLAY OF THE GAME' WITH THE CARMICHAEL DAVE SHOW WITH JASON ROSS"** are not eligible to participate. days prior to “**NOVEMBER 2023 - JIFFY LUBE’S ‘PLAY OF THE GAME’ WITH THE CARMICHAEL DAVE SHOW WITH JASON ROSS**” are not eligible to participate. Persons who have won a prize valued between \$500 and \$999 in the six (6) months prior to “**NOVEMBER 2023 - JIFFY LUBE’S ‘PLAY OF THE GAME’ WITH THE CARMICHAEL DAVE SHOW WITH JASON ROSS**” are not eligible to participate. Persons who have won a prize valued at \$1,000 or more in the twelve (12) months prior to “**NOVEMBER 2023 - JIFFY LUBE’S ‘PLAY OF THE GAME’ WITH THE CARMICHAEL DAVE SHOW WITH JASON ROSS**” are not eligible to participate. - a. **THIRTEEN (13) prizes will be awarded. Each prize consists of ONE (1) \$100 GIFT CERTIFICATE TO ANY PARTICIPATING JIFFY LUBE LOCATIONS IN THE GREATER SACRAMENTO AREA. The Approximate Retail Value (“ARV”) of the prize(s) is \$100.** The winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). The prize(s) are not refundable or transferable, may not be sold to a third party, and may not be substituted or exchanged for cash or credit at any time, nor will they be replaced if lost or stolen. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station or Contest Administrator or Sponsor, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). The Station, in its sole discretion, reserves the right to deny entry to or to remove the winner(s) and/or guest(s) if either engages in disruptive behavior or in a manner with intent to annoy, abuse, threaten or harass any other person at the prize related event(s).
- b. All sales, prizes and other taxes, gratuities and any other incidentals associated with the prizes are the sole responsibility of the prizewinner(s). Prizes are not transferable or exchangeable and may not be substituted, except by sponsors for

The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station are final.

- c. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. The Station's or its Contest Administrator's computer or telephone system is the official time keeping device for this Contest. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address, or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an entrant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good-faith determination that an entrant has cheated or committed fraudulent activity in connection with a Contest, the Station may disqualify that entrant from entering and/or winning this and any or all future Station-administered contests and seek damages to the fullest extent permitted by law.
- b. If due to circumstances beyond the control of the Station, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but does not have the obligation, to cancel, terminate, suspend, or modify the Contest and shall not be required to award a substitute prize(s). If any provision of these Official Rules is irrevocably inconsistent with any provision set forth on the Contest webpage, then the provision of these Official Rules will prevail but solely to the extent of the inconsistency.
- c. Calling the Station regarding the Contest constitutes permission for the Station to tape the caller's voice and use it on the air. All telephone calls during the Contest may be taped without further permission from the caller. By entering the Contest and/or acceptance of prize(s), all entrants consent to the use of their name, photograph, likeness, biography, voice, video, entry materials, prize information (if any), or any statements made for trade, publicity, advertising, or promotional purposes, in any and all media, now known or hereafter devised, including online
